With due respect and humble submission, I Jyoti Gupta, D/O Shri Kamta Prasad Gupta, R/O Vidyasagar Pally, Khalpara, Siliguri, Ward No. 7 would like to inform you that on last night of 2nd May, 2021, one Basant Goyal, S/O Late Sham Lal Goyal addressed at C/O Pankaj Agencies, 33-34, Sevoke Road, Near Bakshi Paul Petrol Pump, P.O. & P.S. Siliguri, District : Darjeeling, West Bengal had assaulted me physically and verbally. The said Basant Goyal had used filthy languages and assaulted me and used criminal force intending to outrage my modesty on 02/05/2021 at about 10:00 P.M near my house.

When I was coming from my relatives house after my dinner, the Basant Goyal and one more person (unknown) in a white wagon R being no. WB74AT5097 had stopped by my side and the said Basant Goyal has shouted with filthy languages looking at me and after that he hold me and assaulted me and after when I screamed they ran away on that white car.

So, therefore, I would like to request you to kindly take the necessary action against him.
