**Sub: FIR against violence, house damage, loot and physical harm on 02 May 2021 night and subsequent day with continued threat to life and property.**

Dear Sir,

1. I, Major Amal Kumar Biswas (Retd), S/O- H/ Captain Swapan Kumar Biswas(Retd), West Dhantala, PO-Satellite Township, Dist: Jalapiguri, WB hereby inform that on night of 02 Apr 2021 at around 2200hrs our house was attacked by Md Badiul(Rafi), Chunabhati and his goons. Md Badiul (Rafi), Liton Ali, Md Ramjan Ansari, Anarul Ansari, Naushad Hussain, Sher Ali, Md Liton Ali preplanned the whole event of attack, violence and loot. At around 2200 hrs Md Badiul (Rafi) and his goons made two teams (one placed on roof of adjoining house owned by Md Ramjan Ansari and another placed next to Md Badiul(Rafi) house. Both the parties started pelting stones targeting our house and when challenged, they went into hiding. Meanwhile a scene was generated in front of our gate under leadership of Md Ramjan Ansari and his sons Anarul Ansari and Anwar Ansari shouting that one stone was thrown at his gate. As preplanned within a minute Md Badiul(Rafi) and his goons arrived on the spot with swords, knives, iron rods and stones and started hurling abuse in filthy language and constantly threatened to kill everybody in the house. They started banging the main gate and tried to forcefully break open it but when failed they immediately encircled the whole house and started pelting stones from all sides. All the window panes were broken, including tiles and marble work. The Puja place where Shivalinga is stationed was also damaged by the stones thrown by these goons. They shouted all communal and Anti Hindu slogans and entered the house by mounting the boundary wall and looted whatever they found at hand including 10 chairs, 3 tarpolines and iron railings. They could not move to the first floor as the door was locked, otherwise there would have been sure loss of lives and massive loot of property. They left with a threat that they will not allow anybody to do any other party other than TMC in the area. The police rep came late at night and clicked photographs of the scene. The situation is very volatile in Chunabhati and West Dhantala as these goons are constantly inciting communal propaganda and giving constant life threat to all family members and Hindus in the area. They are stationed in every corner of road leading to village in massive numbers.
2. These goons again encircled the house on 03 May 2021 morning around 1000hrs. They even called Muslim goons from Fulbari, Jotiyakali, NJP and East Dhantala to increase their number
