I Smt.Priyanka Baishnab Das, W/o. Sri Uttam Das, R/o. Pora Jhar, Radha Krishna Pally, P.S. Matigara, District. Darjeeling would like to inform you that am a married women and my marriage was solemnized with my husband namely Sri Uttam Das on 30/01/2015 as per hindu rites and customs and out of the said wedlock one male baby also born namely Hiyan Das now aged about 3 years and after born of my aforesaid child some dispute arose between me and my husband and our relationship day by day destroyed and during that period in the month of June, 2019 I met with a person namely Rajesh Sarkar, S/o. Dhanjay Sarkar, R/o. Merir Par, Dakshin Gosairhat, P.S.Dhupguri, Dist. Jalpaiguri, and we started to make conversation with each other on over telephone as well as in whatsapp (Ph and whatsapp No. 9547618319 / 7478379532) and during that time he also proposed me and told me that he wants to marry me after gating divorce from my husband and for that reason I along with my husband also filed one mutual divorce case and after few days of our conversation on over telephone I accepted his proposal and during that period he always pressured me to make physical relationship with him but I always denied to did / do the same and told him to marry me after divorce then I will make physical relationship with you and after few months in the month of December, 2019 I along with my above noted minor child fled away with him and started to reside at his rented house situated at Santoshi Nagar, Ward No.05, P.S.Siliguri, Dist. Darjeeling and during that period after taking my advantage the above noted person captured some naket photographs and make some naket vedios of me from his mobile phone and he promised me that he never circulate the said photographs and vedios to others and as well as do / did not circulate the said photos / vedios in any social media side like whatsapp, Facebook etc.

It is important to mention here that during that period the above noted person also used my face book account without my consent and after spending few months It came to my knowledge that the above noted person already married and after it came to my knowledged I asked him why he cheated me and at that time he also assaulted me with fist and blows and told me that if I do / did not make physical intercourses with him then he will circulated the same and after listening the same I tried to leave him but out of fear of circulate the said photos and vedios I could not leave him and thereafter no other alternative way I narrated all the incident to my husband and at that time due to help by my husband I leave him but at the time of leave him he forcefully took my phone Oppo A1K and thereafter I and my husband also withdraw the mutual divorce case and once again started our conjugal life and in the month Decemeber, 2020 my husband noticed that he used my face book account vide account no. [https://www.facebook.com / Onik.as.39](https://www.facebook.com/Onik.as.39) and post some naket photos and vedios in social meadia side and after saw that my husband and I immediately contact with him and request him to delete the same but he denied to do the same and thereafter I after taught the better future of our conjugal retaionship I along with my husband met with him and request him to

delet the same at that time he told me that he will delet all the naket vedios / photos from social media side i.e. facebook as early as possible but ultimately he do / did not delete the same till now and right now said photos / vedios circulated everywhere and my relatives and friends also see / saw the said photos and vedios and right now at the time holi occassion he once again posted some naket photos and vedieos in above noted face book account and also contact with me over telephone and told me that the above noted person ruined my family life after post other naket photos / vedios in facebook so, for the above noted acitivities of the above noted person my prestige and privacy in eye of the society lowed down so, right now I spend my days very bad condition so, no other alternative way today with the help of my husband and well wishers I lodged this Complaint before you against the above noted person.

Therefore, I request you be pleased to drawn your kind attention in respect of my above noted written Complainat and take necessary steps against the above noted person and also be pleased to stop the above mention facebook profile and delete all the naket photos and vedios from the above noted face book profile as early as possible.
