Sir,

In producing herewith one person namely Amal Lohar 50yrs s/o Sri Karma Lohar of Putimari PS, Bagdogra Dist, Darjeeling PS- Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure,

1. One plastic yellow colour container (jar) of local made cholai (each jar containing 5 litters.) marked as Exhibit "A" from which 01 litters randomly taken out as sample and marked as Exhibit "A-1",
2. One plastic Red colour container (jar) of local made cholai (each jar containing 5 litters.) marked as Exhibit "B" from which 01 litters randomly taken out as sample and marked as Exhibit "B-1",
3. One plastic Red colour container (jar) of local made cholai (each jar containing 5 litters.) marked as Exhibit "C" from which 01 litters randomly taken out as sample and marked as Exhibit "C-1",

I, ASI Pradip Kr Roy of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person namely Amal Lohar 50yrs s/o Sri Karma Lohar of Putimari PS, Bagdogra Dist, Darjeeling PS- Bagdogra, Dist- Darjeeling to the effect that today i.e., on 10.05.2021 at about 17.15 hrs in course of performing evening Mobile van duty along with force received source information that one person is selling illicit liquor at Putimari area and huge quantity of illicit liquor is stored in his house. Accordingly I shared the information with you and as instructed had been to Putimari to work out the information. On reaching there at about 17.40 hrs I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as above and stated that he is the owner of the house we cordoning of the house some customers having liquor at the said house seeing the police the fled away. Subsequently the above noted articles were found in the house of Amal Lohar who, being asked failed to produce any valid documents/papers in support of possessing and selling of the liquor and further admitted that he is involved in such trade for last few months. Accordingly I seized the liquor found at his shop under proper seizure list and labelled and also arrested him issuing memo of arrest. The whole process of seizure was made in between 18.05 hrs to 18.40 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Amal Lohar 50yrs s/o Sri Karma Lohar of Putimari PS, Bagdogra Dist, Darjeeling PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
