Monoranjan Das of Bhangapool, P.S - MTG/DJG to the effect that today on 16.05.2021 at 07:55 hrs onwards myself along with force while performing lock down duty near Barsana Hotel area at that time it was found that above noted accused persons were loitering at above noted area with were any face mask with any rhyme and reason which is amounting to Non-Compliance of Govt. Order in c/w Covid-19 pandemic as declared by the State Govt by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Roshan Sahani (31), S/O Lt. Ram Pukar Sahani of Santoshi nagar, P.S - SLG, Dist - DJG, (ii) Bishal Oraon (24), S/O Krishna Oraon of Lichu Bagan, P.S - Matigara, Dist - Darjeeling, (iii) Paritosh Das (49), S/O Lt. Monoranjan Das of Bhangapool, P.S - MTG/DJG under proper section of law and arrange for its investigation.
