Sir,

I, Sri Akash Gupta S/o Sri Ashok Gupta, resident of Ganga Nagar, P.O - Siliguri Bazar, P.S - Siliguri, Dist - Darjeeling would like to inform you that I am running the business of Momo, Chowmin and fast food at Burdwan Road, Santoshi More, P.O & P.S - Siliguri, District - Darjeeling from my shop premises.

On 14 - 5 - 2021 at about 7.15 P.M. I have closed my shop and returned back to my house by observing the guideline of the administration. At about 11.15 p.m. of 14 - 5 - 2021 I came to know that some miscreants have ransacked my shop premises and after having the information I had been to my shop and found that the miscreants have dismantled the signboard of the shop and have severely damaged the shop premises and ransacked the entire shop including food items. After close vigil I came to know that the miscreants have looted a sum of Rs. 3,740/- (Three Thousand Seven Hundred and Forty) only from the cash box which was the sale proceed of the said day. It is to be mention here that after inquiry I came to know that one Siraj Khan S/o Not Known, Sri Sanjit Jha S/o Not Known both are resident of Gwalapatti near Fitness Jim Centre, Ward No - 4, P.O & P.S - Siliguri, District - Darjeeling and one Sonu Mallick S/o not known of Tikiya para, Siliguri, Darjeeling alongwith 5-6 associates have ransacked my shop and damaged my property worth Rs. 30,000/- and looted the money amounting to Rs. 3,740/- Sir I am a very poor man and out of earning from my said shop I was anyhow maintaining my family and due to such act of the offenders I came on footpath.

So, you are hereby requested to investigate the matter and take necessary legal action against the offenders for the interest of justice.
