(B) Gopal Roy (55) yrs S/O-Late Shibeswar Roy of Ganga Nagar, Road No-2, Ward No-5, P.S-Siliguri, Dist. Darjeeling, iii) Rahamatulla Mia (47) yrs. S/O-Late Muniruddin Ahamed of Adarsha Nagar Math, Ward No-4, P.S-Siliguri, Dist. Darjeeling, and iv) Biswajit Barman (55) yrs.S/O-Late Kolindra Nath Barman of Ghugumari, Near Ghugumali High School, Ward No-36, P.S-Siliguri, Dist. Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19... The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country.
