Finding no other alternative way I apprehended them to avoid risks to human life and health as they violating the provisions of Government rules as convey by the health ministry in the pretext of COVID-19 spreading in India.

Under the above facts and circumstances, I request you that a specific case against the aforementioned person may kindly started with suitable sections of law.
