In producing here with the following 06 (Six) arrested persons under arrest namely (1) Balaram Ghosh (69) S/O- Late Madhusudhan Ghosh of Haidarpara Sarat Chandra Pally near Transforma, Ward No- 40PS- Bhaktinagar Dist- Jalpaiguri (2) Arun Choudhury (72) S/O- Late Niranian Choudhury of near Gouranga-pally Haiderpara, Near Gouranga Pally Bazar Ward No- 40 PS- Bhaktinagar Dist- Jalpaiguri, (3) Radha Raman Paul (65) S/O- Late Haripada Paul of Haidarpara near Pally Mangal Club, Ward No- 40 PS- Bhaktinagar Dist- Jalpaiguri, (4) Gopal Sarkar (52) S/O- late Kalachand Sarkar of Haidarpara near Pally Mangal Club, Ward No- 40 PS- Bhaktinagar Dist- Jalpaiguri, (5) Fuleswar Deb Sharma (59) S/O- Late Sashimohan Deb Sharma, Haidarpara Sarat Chandra Pally near Transformer, Ward No- 40 PS- Bhaktinagar Dist- Jalpaiguri and (6) Manindra Sarkar (54) of Haidarpara near Pally Mangal Club, Ward No- 40 PS- Bhaktinagar Dist- Jalpaiguri under arrest u/s 41 Cr.PC.

I SI Sibdhan Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons to the effect that today i.e 20.05.2021 in between 14:30 to 17:10 hrs while myself along with ASI Rabin Lama, ASI Biswajit Saha and other forces of Bhaktinagar Police Station had been to Sarat Chandra Pally under Bhaktinagar and found the above noted persons were moving there without any rhyme and reason during lockdown and not maintaining any social distancing which has been duly promulgated by Govt of West Bengal. On being asked the above noted persons stated before me that they had well aware of the pandemic situation and they supposed to remain at home and not to come out without any reason. Hence, they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State.

Accordingly, I arrested them u/s 41 Cr.P.C in c/w the above case. Hence, I request you for starting a specific case u/s 188/209 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
