Respected Sir,

I Puneet Dwivedi, S/o
Dwivedi, R/o Sonari Mill Complex, SF Road,
Siliguri am the legal owner of 'The
Swedish', The Next Level Pub' situated at the
Planet Mall, Siliguri. On 23rd October, 2020,
I had given The Swedish on Management
Lease to a said 'Amar Gupta' S/o of
Santosh Gupta, R/o cl/o Shubhrath Ghosh
(Nirmal Gas), next to Krishnadev Bhawan,
Sreemaa Sarani, Batupara, Siliguri only
to run and sell food as liquor licensee
cannot be given on lease or transferred
before 5 years. I had handed him
the property keys without any legal
agreement as the court was closed for
Durga Puja so it was decided that after
Durga Puja Amar Gupta could sign the
Management Lease agreement for selling
food in The Swedish. After Durga Puja when
I called him, he denied to sign the
agreement and I came to know
through ~~sources~~ sources that he is
selling alcohol at The Swedish which
he obviously didn't buy from excise
P. didn't hand over the Id and
T. card from where all excise

License owners are supposed to buy alcohol. Continuously following up with him on November and December to sign the agreement, I had no option but to give a written complaint against him in January to the Silguri Commissionerate and Superintendent of Excise, Jalpaiguri. I had also informed the same to the ^{Aman} Police Station that Aman Bhaktinagar Police Station: that Aman Gupta has illegally captured The Swedish and has been doing illegal business there.

Yesterday on 20th May, 2021, there was a raid held by the Baktinagar P.C. in the Swedish and they found illegal alcohol and party going on in this pandemic situation. I would like to inform once again that Aman Gupta had captured The Swedish illegally and is running alcohol illegally at the property. I would also like to inform you that in the month of March every year, we exca license holder have to renew our license by paying ₹5,00,000. I didn't renew my license this March, 21 as Aman Gupta hasn't paid me a single penny since November. So, by law Aman Gupta cannot bring alcohol at the Swedish after March 21.

I am really thankful to the Bhaktinagar Police for taking strict

action against Arun Gupta yesterday. By organising a party during this pandemic situation and also selling alcohol and hookah after capturing my property The Swedish, he has also embarrassed me in front of the citizens of Siliguri as many people know I am the owner and are of the view the P was involved in yesterday's party. Also I would request the concerned authorities to take strict action against Arun Gupta for capturing The Swedish and running alcohol illegally and after yesterday also defaming and embarrassing my reputation and my brand, The Swedish reputation in front of Siliguri citizens. I would also request a strict action to be taken against him if he again tries to capture The Swedish illegally.
