I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar Police station, SPC do here by lodge a written complainant against six (06) accused 1) Netal Das (55) S/O Late Kala Chand Das of Sarada Pally W/no 37 PS Bhaktinagar Dist Jalpaiguri (2) Mahadeb Das (42) S/O Late Sunil Ch Das of Dabgram W/no 23 PS Siliguri Dist Darjeling (3) Abhimunnya Sikdar (70) S/O Late Paresch Sikdar of Shantinagar Bou Bazar PS Bhaktinagar dist Jalpaiguri (4) Dipak Mandal (34) S/O Madhu Sudhan Mandal of do (5) Bhola Haldar (38) S/O Jiban Haldar of Telipara PS Bhaktinagar Dist Jalpaiguri and (6) Ratan Roy (40) S/O Late Puteshwar Roy of Ghugumali bazaar PS Bhaktinagar dist Jalpaiguri, to the effect that today on 22.05.2021 at 07.55 hrs myself along with ASI Sumir Baran Nath C/134 Ginen Basumata and CV/616 Ananda Das while performing patrolling duty in connection with Covid-19 situation at Ashighar OP area vide Ashighar OP GDE no. 453 dt 22.05.2021, at about 12.45 hrs found that the above noted persons were roaming in OP area without wearing Mask and without any purpose which has been duly promulgated by Government of West Bengal due to crucial situation of corona virus though the Government has abstained them not to come out of the house without any emergency requirement as it is very dangerous for our society at this stage. As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 79-CS/2020 dated 12.04.2020, Vide memo no. 486-CS/2021 dt 24.04.2021 and also announced lock down from 16th may to 30th May vide memo no. 647-ISS/2M-22/2020 dt 15.05.2021, as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duly promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India, I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply any lawful instructions and kept on roaming within the area without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.

Therefore, I pray before your kind honour that a Specific case may kindly incited against the accused persons namely (1) Netal Das (55) S/O Late Kala Chand Das of Sarada Pally W/no 37 PS Bhaktinagar Dist Jalpaiguri (2) Mahadeb Das (42) S/O Late Sunil Ch Das of Dabgram W/no 23 PS Siliguri Dist Darjeling (3) Abhimunnya Sikdar (70) S/O Late Paresch Sikdar of Shantinagar Bou Bazar PS Bhaktinagar dist Jalpaiguri (4) Dipak Mandal (34) S/O Madhu Sudhan Mandal of do (5) Bhola Haldar (38) S/O Jiban Haldar of Telipara PS Bhaktinagar Dist Jalpaiguri and (6) Ratan Roy (40) S/O Late Puteshwar Roy of Ghugumali bazaar PS Bhaktinagar dist Jalpaiguri and arrange it investigation as per proper section of law.
