Sir,

With due respect, I Smt. Sashibala Roy or Tapashi Roy, W/o Sri Pradip Roy, resident of Purba Dhantala, P.O.- Satellite Township, P.S - NJP, District - Jalpaiguri, would like to inform that on 13-5-2021 at about 8.30 pm, on the issue of urinal of dog on the scooter of Uttam Roy, Uttam Roy has/had not put any objection. But one Anjana Tiwari, W/o Not Known of Purba Dhantala has started abusing me and when I raised my objections, she caught hold me and started assaulting me with bamboo sticks and to support the said Anjana Tiwari, one Seema Ghosh, W/o Mintu Ghosh and Minati Mahanto, W/o Ranjit Mahanto, all are of Purba Dhantala, have started assaulting me by felling me on the ground and tried to kill me by rounding shari in my neck and have snatched my Silver chain of my neck weighing about 30 grams valued 15,000/- (aprox) . In the mean time, my husband came forward to rescue me but the antisocials of said Anjana Tiwari, namely Ranjit Mahanto, Manish Dhobi, Jaggu Dhobi, Kajal Dhar, Pushpajit Roy, Basu driver and Ramchandra fruitwala, all are of Purba Dhantala, have started assaulting my husband by fists and blows. But due to intervention of my husband and my daughter, I was rescued. Subsequently, they called police by levelling false allegations and police detained my husband in the said night of 13-5-2021.

After taking custody of my husband, the above named persons have again assaulting me in the said night of 13 - 5 - 2021 and still they are threatening me and my husband with dire consequences.

Due to pain in my body and neck and due to continuous treatment by doctor, I could not lodge my complaint before you within time.

The above named ladies are habitual quarrelling summs ladies of the locality and used to pick up hue and cry with the local residents without any reasonable cause.

So, requesting you to look into the matter and take necessary legal actions against the above named persons for which I will highly be oblige to you.
