Dear Sir,

This is to bring to your kind attention that on the night of 20/21 May 2021 there has been a big theft in my premises Soubhagya Palace Banquet, 1 Udham Singh Sarani, Sevoke Road Siliguri.

On the night of 20/21 May 2021 some thieves climbed on the roof top from the adjacent Ghosh Nursery Building at about 2 to 3 AM of 21 May 2021, by creating a hole in the wall at 4th floor Stairs Landing and then jumped on to the Soubhagya Palace Roof top. Here there are Four outdoor units of the Central AC system. The thieves have cut the Aluminum pipes of all the Four Out door units of the AC and taken the same with them. Thus 40 KG of Gas of the four units have also leaked which itself cost Rs. 75 to 80 Thousand. Thus the total damage of the theft is beyond Rupees One lac please.

Sir you are requested to please take action to catch these thieves and take all necessary actions so that such dairying incident of theft is not happening in this locality. Looking forward for your necessary action please.
