In producing herewith four arrested accused persons namely Mahinder Mahaseth (58) S/O Late Bokai Mahaseth of Tikiapara, Matangini II, Ward No. 28, PS-Siliguri , Dist-Darjeeling along with seized articles vize i) 25 (twenty five) sealed bottles of Himalayan Gold to up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal, ii) one black color plastic carry bag as per seizure list.

1, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused persons namely Mahinder Mahaseth (58) S/O Late Bokai Mahaseth of Tikiapara, Matangini II, Ward No. 28, PS-Siliguri , Dist- Darjeeling to the effect that on 24.05.21 at 18.25 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Tikiapra, Matangini-II, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS case no. 1213 dated 24.05.21 and informed the fact to I/C Siliguti PS. As per his direction I along with ASI Subir Sen , ASI Siben Sarkar, CV-622 Ramanath Barman, CV-283 Prosenjit Dey left for Tikiapra, Matangini-II under Siliguri PS vide Siliguri P.S GDE NO: 1214 to verify the veracity of the information. On reaching at 18.45 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot, but we managed to apprehend him and on interrogation, the above noted person disclosed his identity as noted above. On searching we found that i) 25 (twenty five) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal, ii) one black color plastic carry bag. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure was made in between 19.45 hrs to 20.05 hrs. On being asked he stated that he used to sale the same to locality without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him U/S-41 Cr.P.C after observing all sorts of rules for selling the said country made sprit without any valid license. It is also like to mentioned that the above noted accused person also violated West Bengal Order against Pandemic Covid-19 vide Order no. 486-CS/2021 dated 24.04.21 arising out of order no, 79-SC/2020 dated 12.04.20 and Order no. 647-ISS/2M-22/2020 dated 15.05.21 to prevent spread of Covid -19. The above noted accused person has intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break out of pandemic Covid -19 throughout the country.
