Subject: - F.I.R

Sir,

In producing herewith one accused person namely Amalesh Saha (M/46), s/o- Lt. Subol Ch. Saha, of- Sukantanagar, Near- Haldi Mill, W/No. 38, PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure:

(1) 15 (fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total-09 Liter & Amount Rs 1500/-

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Amalesh Saha (M/46), s/o- Lt. Subol Ch. Saha, of- Sukantanagar, Near- Haldi Mill, W/No. 38, PS Bhaktinagar Dist Jalpaiguri to the effect that, on 28.05.2021 at around 23.05 Hrs as per order of O/C Ashighar OP I along with C/ 877 Munna Ahamed, and CV/1016 Amrit Roy all are of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP vide Ashighar OP GDE no. 639 Dt 28.05.2021. During the course of which I received information from my source that one Amalesh Saha stored a huge number of bottles of illicit liquor and Chullu inside his house at Sukantanagar and used to sell it to the local youth at higher rates. I immediately informed O/C Ashighar OP and as per his kind direction and without wasting anytime I along with my accompanied party left for Sukantanagar area to verify the veracity of information. On the way I called two local persons namely (1) Dillip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Sanat Das (31) S/O Mangal Das of Niranjan Nagar w/no 36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Sukantanagar, Haldi Mill area and as indicated by my source I held raid at the house of Amalesh Saha. But seeing us the above noted accused person tried to flee away from the spot and during that time he fell down in a high drain and received some minor superficial injuries over his body. I along with my force rescued him from the high drain and apprehended him. I searched at the house of above noted accused person and during the course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrested the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 23.55 hrs and 00.35 hrs on 28.05.2021/29.05.2021 respectively.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Amalesh Saha (M/46), s/o- Lt. Subol Ch. Saha, of- Sukantanagar, Near- Haldi Mill, W/No. 38, PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
