In producing here with the accused person namely-Sanjoy Mahato (29) yrs, S/O-Late Binda Mahato of Adarsha Nagar colony, Near house of the Arjun Sahani, ward No-4, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 62 (Sixty Two ) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 6,200/- (six thousand Two hundred) in which 01 (one) bottle taken as sample and

I beg to report that today i.e. On 29-05-21 while performing special raid against illegal alcohol, at 08.45 hrs, I received a source information that one persons namely- Sanjoy Mahato (29) yrs, S/O-Late Binda Mahato of Adarsha Nagar colony, Near house of the Arjun Sahani, ward No-4, P.S-Siliguri, Dist. Darjeeling, he is selling huge alcohol in his house of the accd. Persons at Adarsha Nagar colony, ward No-4, P.S-Siliguri, Dist. Darjeeling. Under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Adarsha Nagar colony, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No -925/21 Dated- 29-05-.21. After reaching Adarsha Nagar colony,, Siliguri, Darjeeling at 08.55 hrs and as shown by the source. I found the above noted person are selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him . On being asked the arrested accused disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in the house of the accd. Person a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person are selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 09.05 hrs to 09.45 hrs On 29-05-.21.

And also the above noted accused person violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, and Order No-647-ISS/2M-22/2020 DATED 15-05-21, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested him U/S-41 Cr.P.C, after issuing proper arrest memo and maintaining health

Under the circumstances one specific case may kindly be started against the arrested accused person namely-Sanjoy Mahato (29) yrs, S/O-Late Binda Mahato of Adarsha Nagar colony, Near house of the Arjun Sahani, ward No-4, P.S-Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
