1, SI Sajal Roy of Bhaktinagar P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Dipankar Das @ Deep(20) S/O Lt Deban Das of no -02 Jyoti nagar, Isckon Road W/no-40 PS- Bhaktinagar Dist-Jalpaiguri (2) Tapash Halder (25) S/O Lt Gedu nath Halder no -02 Jyoti nagar, Isckon Road W/no-40 PS- Bhaktinagar Dist-Jalpaiguri, and (3) Bishnu Barman (24) S/O Subhash Barman of Vivekananda nagar, Near Shib Mandir W/no-42 PS-Bhaktinagar Dist-Jalpaiguri under arrest along allowing with following articles; (i) One (01) one knife measuring approx. 14" including handle recovered from the possession of Dipankar Das (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from the possession of Tapash Halder and (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Bishnu Barman, which he was holding on his hand.

In this regard, I beg to report that on 01.06.2021 at 01.25 hrs received secret reliable source information that about 10/12 anti socials armed with deadly weapons assembled at Ektiashal Hat area making preparation to commit dacoity at Haiderpara area. I informed the source information to IC Bhaktinagar PS and noted the information vide Bhaktinagar PS GDE No. 1674 Dated 01.06.21 As per the direction of IC Bhaktinagar PS, at 01.35 hrs, I along with ASI Biswajit Saha .ASI Rabin Lama, CVF/619 Dharmendra Roy, CVF-935 Biplab Roy left for working out the information vide Bhaktinagar PS GDE No. 1675 Dt. 01,06.21 after briefing officer and force properly and also along with required papers / articles. At around 02.05 hrs we reached near Ektiashal Hat side and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards Ektiashal Hat looking for witnesses, if any on the way and found witnesses namely; (1) Malin Ch Roy (23) s/o Monoranjan Roy of Dakhin palash, Naturn bazar PS -Pradhannagar Dist.-Darjeeling and requested him to be present during search and seizure if any. By the time we reached Ektiashal hat, as informed by secret source, in faint light of street lights on the west side corner, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted three persons could be apprehended and detained. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 8/9 others assembled at the spot making preparation to commit dacoity tonight at Haiderpara area. I accordingly searched them in presence of witnesses and found (i) One (01) one knife measuring approx. 14" including handle recovered from the possession of Dipankar Das (knife was on his hand) (ii) One iron rod measuring approx, 30" pointed at one end (seemed to be implement of house breaking) recovered from the possession of Tapash Halder and (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its
