In producing herewith one accused person namely Malin Roy (28) s/o Lt. Baishaku Roy of Dakhin Ektiashal, near Ektiasal Hat, Word No- 40, P.S Bhaktinagar, Dist.-Jalpaiguri -along with seized articles i.e. (1) 06 (six) bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufactured by Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal. And (2) 35 (Thirty Five) bottles of Himalayan Gold. 60 up country spirit containing 300 ml. each manufactured by Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal.

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Malin Roy (28) s/o Lt. Baishaku Roy of Dakhin Ektiashal, near Ektiasal Hat, Word No- 40, P.S Bhaktinagar, Dist.-Jalpaiguri to the effect that today on 02.06.2021 at 18.50 while I was performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO-98 date 02.06.2021, received a specific input from the source that the above noted person is selling illicit liquor to his design customers in open market Ektiasal Bazar for his wrongful gain. Accordingly the fact is informed to I/C Bhaktinagar PS and as per his kind direction I along with ASI Biswajit Saha, ASI Biplab Kumar Das , ,CV-619 Dharmendra Roy, CV-14 Labanyamoy Barman left for Ektiasal Bazar under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the Place-where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same in bush near pipe line in conceal position. On searching found huge numbers of Himalayan Gold country made spirit. On being interrogation he could not produce any valid documents/license in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 08 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 20:25 hrs to 20:55 hrs. On being asked he stated that he kept the same with a view to sale and supply at Ektiasal bazar area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license

Therefore I pray before your honour that a specific case may kindly be started against Malin Roy (28) s/o Lt. Baishaku Roy of Dakhin Ektiashal, near Ektiasal Hat, Word No- 40, P.S Bhaktinagar, Dist.-Jalpaiguri as per proper section of law.
