I, UPAMANYU CHAKRABORTY, S/o Soumitra Chakraborty, resident of Siliguri, would like to report that I was carried away by lucrative offers on camera lenses by Mr. Adam Scott. from Facebook (profile URL: <http://www.facebook.com/profile.php?id=100038676676825>) and I decided to make a purchase of 3 products (Totina 10-17 mm, DJI Mavic mini, Dicapag underwater bag) worth rs. 60,000.00. on 28th May, I paid rs. 20,000 and additional rs. 10,500.00 on request. Then on 30th May, I paid him 10,000 rs more for import-export license as he asked. Today, I tracked the shipment from tracking ID (www.trackingfrommars.com; Tracking ID: TE2202697IN) & it showed that the parcel was held as customs at Delhi, and it will need 17,500.00 to clearance & stamp checked. So, I paid him 17,500.00 rs. and 2,500 rs and cleared the total amount 60,000.00. now, he is asking for more money and otherwise I'll lose the whole money, he threatened.

Therefore I request you to take necessary steps to find out the culprit and oblige and please help me to get my money back.
