Mintu Khan (30yrs) S/O- Md. Mufiz Khan of Adarsha Nagar, Govt Sawmil, Ward No-4, PS-Siliguri, Dist-Darjeeling, (iv) Shiba Das (23yrs0 S/O- Samal Das of Surja Sen Colony, Block-C, PS-NJP, Dist-Jalpaiguri, (v) Kishore Rawat (33yrs) S/O- Chandrika Rawat of Gate Bazar, North Colony, Ward No-34, PS-NJP, Dist-Jalpaiguri, (vi) Suman Chandra Dey (29yrs0 S/O- Lt. Santosh Chandra Dey of Ambika Nagar, near Master plan math, PS-NJP, Dist-Jalpaiguri, (vii) Md. Firdos (26yrs) S/O- Lt. Md. Yaqub of Tikiapara, Mazdoor Colony, Ward No-28, PS-Siliguri, Dist-Darjeeling, (viii) Manoranjan Barman (35yrs) S/O- Bhuben Barman of Kawakhali, near Dishan Nursing Home, PS-Matigara, Dist-Darjeeling alongwith their five vehicles viz- (i) Toto green colour bearing No. WB 73F/4958, (ii) Toto red colour bearing Reg No- WB 73F/3227, (iii) Toto red colour without number, (iv) Toto green colour bearing No- WB 73F/2367 & (v) Toto green colour without number. I SI Swapan Basu Biswas of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 04.06.2021 at 12.05 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming along with their respective vehicles without wearing mask on their face and without any proper reasons. Five of them were roaming with their vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
