- (2) 10 (Ten) bottles of King fisher strong premium Beer each contain 650 ML and Rs. 130/- (One hundread thirty) only. Total value Rs. 1300/- (Thirteen hundread) only.

I ASI Anupam Roy of NBMC OP lodged a written complaint against the accused person namely Dhiren Roy (Male/58 yrs), S/O – Lt Narendra Nath Roy, of – Kawakhali Bazar, PS – Matigara, Dist – Darjeeling to the effect that, on 05.06.2021 as per order of O/C NBMC OP I along with force C/131 Kanuram Sarkar & CV/638 Partha Biswas, & CV/920 Kamal Barman all are of NBMC OP with Govt. vehicle no WB74/8035 were holding raid against anti social elements, warrentees, ID liquor etc in different area under NBMC OP in course of which I received information from my source that one Dhiren Roy stored a huge numbers of bottles liquor inside his shop Near at Kawakhali Bazar and used to sell to the local youth in higher rates for his illegal monetary gain. I immediately informed O/C NBMC OP and as per his kind direction wasting no time I along with my accompanied party left for Kawakhali bazar area to verify the veracity of information. On reaching at Kawakhali bazar area as indicated by my source I held raid at the shop of Dhiren Roy at kawakhali bazar. But seeing us the above noted accused person try to flee away from the spot, but we managed to apprehend him. I held through search in the shop of above noted accused person, in course of search I recovered the above noted bottles of liqure from inside his shop. I seized the above noted articles as alamat of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search, seizure and arrest were made in between 14.45 hrs to 15.15 hrs on 05.06.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Dhiren Roy (Male/58 yrs), S/O - Lt Narendra Nath Roy, of - Kawakhali Bazar, PS - Matigara, Dist - Darjeeling and arrange for its investigation.
