In producing herewith the arrested accused person namely (1) Irfan (29yrs) s/o Ummar Mohammad of Maliki, Bharatpur, PS-Gopalgarh, PO-Pahari (Rajasthan) along with the seized (1) Vehicle No. RJ02GC-1486 (Articulated Vehicle) loaded with Stone Chips, I beg to submit that tonight on 06/07.06.2021 at 01.45 hrs in course of my Naka duty at Gossainpur, More, vide GDE No. 258 dtd 06.06.2021 and MCC.
