I, SI Srimanta Chatterjee of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodged a written complainant against the above noted person to the effect that on 04.06.21 myself along with force while performing Naka checking duty at Jhankar More under Siliguri PS (This refers to Khalpara TOP GDE No-108 dated 04.06.21) found one motor cycle was coming from Timulpara side. I gave signal to stop him but he try to fled away from the spot. On hot chase we apprehended him, on checking I recovered the above noted articles from one bag which was hanged in his bike. On demand he could not produce an valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in open market for his wrongful gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and level and took signature of the accused person one bottle taken as sample. (The seizure was made in between 22.20 hrs to 23.45hrs) I arrested the accused person u/s 41 Cr.pc. and issued Memo of arrest appraising the ground of arrest.
