The matter was diarized in DD, SPC GDE No. 52, Dt-06.06.2021 and subsequently, I informed the matter to the ACP, DD, SPC and being directed, myself along with ASI Proloy Bhattacharjee, ASI Abu Taleb, Const- 371 Sushanta Dey, and Const- 932 Pabitra Das all of DD, SPC along with investigation kit left for Saheed Nagar More under PS- Bhaktinagar by govt, vehicle to verify the veracity of the information vide DD, SPC GDE no. 53, Dt- 06.06.2021 and M.C.C No- 176/2021 Date- 06.06.2021. We were assisted by SI Rasbihari Saha and ASI Blood Jha of SOG, SPC.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Saheed Nagar More and at about 15.00 hrs, on being point by source betained the above noted vehicle having number plate WB 57-C 9452 inside who the above noted three accused persons were found sitting. Above noted Alomgir Sekh verband sitting at driver's seat, two others were found sitting beside the driver's seat. Thereafted a stated our identity and the information in hand and stated them that they will searched in person for the purpose. At this, they after disclosing their identity as noted about their designed customers as per requirement.

Inen gave them option whether they wanted to be searched in presence of Executivity and Cazetted Officer. Then they agreed to be searched in presence of any of the above. Accordingly, I informed the matter to Sri Abunur Hossain, ACP, HQ, SPC wholding the charge of Special Executive Magistrate under SPC area for today, for acting Special Executive Magistrate, regarding the interception of the accused persons suspected be possessed Brown Sugar and requested him to come at Bhaktinagar Saheed Nagar More remain present and to supervise the search and seizure.

Accordingly at 15.35 hrs Abunur Hossain, ACP, HQ, SPC arrived at the spot as Spe Executive Magistrate, SPC and subsequently, under his supervision in presence of witnesses process of search of the detained persons as well as the vehicle having number plate WB 5 9452 was conducted following all formalities keeping their decency and recovered the ab noted articles from the exclusive, conscious and joint possession of above noted three accupersons. Subsequently, being demanded in presence of Sri Abunur Hossain, ACP, HQ, acting as Special Executive Magistrate, SPC the detained persons failed to produce any vidocument in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and for total 350 grams & 30 gram of said to be Brown Sugar exclusive and joint possession of accurate persons namely Alomgir Sekh, Md. Ansar Sekh and Rejabul Haque and marked as "Exhibit and Exhibit-B". I also taken 10 grams and 05 grams of said to be Brown Sugar respectively for Exhibit-A & Exhibit-B and Marked as Exhibit-A1 & Exhibit B-1 as sample for examination. The seized the above noted articles at the spot under proper seizure list duly signed by the above noted witnesses and the Special Executive Magistrate, SPC and acknowledged by the accurate persons. I also labeled and sealed all the articles in presence of Sri Abunur Hossain, ACP, SPC acting as Special Executive Magistrate, SPC and witnesses and accused persons. The witnesses of seizure was made in between 15.45 hrs to 17.00 hrs. Due to lock Down independent witness could be found.

Being further asked, the apprehend persons namely Alomgir Sekh, Md. From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons Alomgir Sekh, Md. Ansar Sekh and Rejabul Haque are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (i) Alomgir Sekh(/45), S/O Late Mansur Ali of of Vill- Dakshin Latiber Para, PO- Bansgaon, PS- Lalgola, Dist-Murshidabad (ii) Md.
