They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647-ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Kartik Namadas (62) S/O Lt.
