In producing herewith three accused persons namely i) Rahul Roy (20) S/O Kamal Roy of Kukilmani Asharam, Jaleswari Petrol Pump, PO- Sahudangi PS-NJP Dist- Jalpaiguri, (ii) Ratan Roy (20) S/O Mantu Roy of Baladangi, PO- Barodangi, PS- Dinhata, Dist.- Cooch Behar, (iii) Subhankar Sarkar (19) S/O Manik Sarkar of Sharmiknagar, Bharatnagar PS- Siliguri, Dist.- Darjeeling along with the following seized article, as per seizure list.

- i) One Honda Shine Motor Cycle Grey in colour without number plate having Engine No- JC85/E-D-0119203 and Chassis No.- ME4JC851HLD044531.

I, ASI Sajal Das of NJP Police PS, SPC do hereby lodged this written complaint against the above mentioned accused Persons to the effect that on 07.06.2021 at 00.05 hrs received reliable secret source information that three persons are coming by a motor cycle without displaying any number plate from Cooch Behar side and proceeding towards Siliguri via Ambari Road, Jalpaiguri to sale the said motor cycle in Siliguri area. I diarized the matter in GD vide NJP PS GDE No 280/21 at-00.05hrs Dated 07.06.2021 and informed the fact to you and as per your kind direction myself along with C/1053 Paresch Rava CV/116 Rohit kr Mahato and CV/824 Niru Kumar Yadav left for Bhabesh More, PS- NJP, Dist.- Jalpaiguri to verify the veracity of the information. At 00.25 hrs myself along with police team arrived at Bhabesh More and ambush there to work out the information. After a while we found one motor cycle is coming from ambary side with three persons. Our Police team instructed them to stop their motor cycle but on suspicious manner they tried to fled away from the spot but after a hot chase we managed to apprehend them at near Bhabesh More. On being asked, they disclosed their name and identity as mentioned above. On demand they failed to produce any valid documents in support of the motor cycle. On further interrogation, they admitted that they have stolen the said Motor cycle from Cooch Behar and proceeding towards Siliguri for its clandestine disposal at Siliguri PS area. On search I found the Engine number and chassis number of the said motor cycle is Engine No- JC85/E-D-0119203 and Chassis No.- ME4JC851HLD044531. There was sufficient reason to believe that the said motor cycle is stolen one. Accordingly I seized the said motor cycle (Honda Shine) Grey in color without displaying any number plate having Engine no- Engine No- JC85/E-D-0119203 and Chassis No.- ME4JC851HLD044531 under proper seizure list from the possession of the above noted accused persons and arrested them under proper memo of arrest and observing all the formalities of arrest, search seizure and arrest made between 00.45 to 01.15 hrs.

Under the above nopted fact and circumstances, I therefore pray to you that a specific case under propedr section of law may kindly be registered against accused namely i) Rahul Roy (20) S/O Kamal Roy of Kukilmani Asharam, Jaleswari Petrol Pump, PO- Sahudangi PS-NJP Dist- Jalpaiguri, (ii) Ratan Roy (20) S/O Mantu Roy of Baladangi, PO- Barodangi, PS- Dinhata, Dist.- Cooch Behar, (iii) Subhankar Sarkar (19) S/O Manik Sarkar of Sharmiknagar, Bharatnagar PS- Siliguri, Dist.- Darjeeling and arrange for its investigation.
