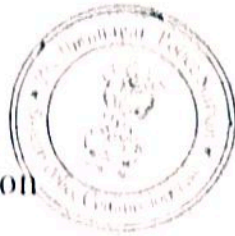

Subject: FIR.

Sir,

In producing here with one arrested accused persons namely 1) Puskar Tamang(39) S/O Lt Bir bahadur Tamang of Darjeeling N.P road Darjeeling P.S Sadar Darjeeling ,Dist-Darjeeling arrested U/S 41 CrPC and do hereby lodge a written complaint against him.

In this regard I beg to complain that on 08.06.2021 while performing special van duty vide GDE No.391 Dated 08.06.2021 at around 18:00 hrs I found that the above noted person was gathering inside his Goods carrier with some other people bearing registration number WB73C3970 without wearing mask and his said vehicle loaded with goods At Champasari area. As he violated the order No.- 647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3<sup>rd</sup> June, 2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I along with force apprehended him and found that the above noted vehicle was loaded with non essential goods. Finding no other alternative and I arrested him U/S 41C.rPC and seized the vehicle with goods under proper seizure list. On interrogation, he disclosed his name and address as noted above. On further grilling, he admitted that he was aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid 19 and he stated that he was heading towards Darjeeling with his above noted goods carrier with non essential goods.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
