Sir,

In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Subash Roy (39yrs) S/O- Bhabesh Roy fo Krishnanagar Colony, near Bhabesh Petrol Pump, PS-NJP, Dist- Jalpaiguri, (ii) Biswanath Roy (28yrs) S/O- Lt. Bhabesh Roy fo Alo Chowdhury More, PS-Siliguri, Dist- Darjeeling, (iii) Animesh Das (24yrs) S/O- Alok Kr. Das of near Dadabhai Club, PS-Siliguri, Dist- Darjeeling, (iv) Arbind Kumar Sha (43yrs) Nandalal Sha of Hemanta Basu Colony, near Shiv Mandir, Ward No-4, PS-Siliguri, Dist-Darjeeling, (v) Dilip Chowdhury (48yrs) S/O- Lt. Jagdish Chowdhury of Milanpally, Sukanta Sarani, Ward No-26, PS-Siliguri, Dist-Darjeeling, (vi) Sahadeb Mandal (55yrs) S/O- Lt. Haripada Mandal of Milanpally, Housing More, Ward No-25, PS-Siliguri, Dist-Darjeeling along with their vehicles bearing Nos viz- (i) Toto blue colour without number, (ii) one Scooty bearing Reg No. WB 74BE/4383 & (iii) Toto grey colour without number. I, SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 08.06.2021 at 09.45 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Three of them namely Subash Roy, Animesh Das and Arbind Kr. Sha were roaming with their respective vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
