Sir,

In producing herewith the following accuseds namely (1) Ajit Roy (23) S/O Lt.Pranballav Roy of Dakshin Shantinagar,Binaymore P.S Bhaktinager Dist. Jalpaiguri (2) Raj Mandal(20) S/O Akhil Mandal of do (3) Soumitra Roy (21) S/O Shibu Roy of Bholanath Para Thakurtala PS Bhaktinager Dist Jalpaiguri (4) Palash Barman (23) S/O Purna Barman of do, and (5) Subhankar Sarkar (24) S/O Nirmal Sarkar of Purba Fakdaibari PS Bhaktinager Dist. Jalpaiguri, in custody along with the following seized articles:-

- i. One(1) Khukri measuring about 13 inches in length made of iron including its Wooden butt was recovered from the possession of accused Ajit Roy (23) S/O Lt.Pranballav Roy of Dakshin Shantinagar,Binaymore P.S Bhaktinager Dist Jalpaiguri
- ii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Raj Mandal(20) S/O Akhil Mandal of Dakshin Shantinagar,Binaymore P.S Bhaktinager Dist. Jalpaiguri
- i) One (1) iron made Chopper measuring approx 16 inches length including wooden handle recover from the possession of accused Palash Barman (23) S/O Purna Barman. of Bholanath Para Thakurtala PS Bhaktinager Dist Jalpaiguri.
- ii) One (1) iron sword measuring about its 2 ½ ft including iron blade and wooden handle, recovered from the possession of accused Soumitra Roy (21) S/O Shibu Roy of Bholanath Para Thakurtala PS Bhaktinager Dist Jalpaiguri.

I, S.I Paramartha Barma of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 09/10 other unidentified persons to the effect that today i.e. on 08.06.2021 at about 21.05 hours received a secret source information that a group of 14-15 persons have assembled at Shahu River bed Near Tharughati forest, under Bhaktinager P.S, Dist-Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to I.C, Bhaktinager P.S and diarised the whole fact in Ashighar OP GDE No.194 dated 08.06.2021. Then at 21.10 hrs, as per instruction of O.C Ashighar OP I along with ASI Ujjal Mandal , ASI Sumit Baran Nath C/729 Dinesh Ch Roy . CV/1016 Amrit Roy all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO.195 dt- 08.06.2021. We reached near the spot as directed by the source at about 21.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. On way we met two respectable persons of the locality namely (1) Shankar Mandal (38) S/O Late Sunil Mandal of Ashighar Coloney PS Bhaktinager dist. Jalpaiguri and (2) Sujit Roy (35) S/O Sachin Roy of Naresh more Telipara PS Bhaktinager dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if any search and seizure is necessary for the purpose and they agreed. We reached at the Shahu River bed near Tharughati forest at about 21.50 hrs and found a group of 14-15 persons sitting at the Shahu River bed near Tharughati forest. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 05 above referred accused persons. After apprehension the 05 persons disclosed their identity as noted above and also stated that there were 09/10 other persons with them and they were planning to commit a

dacoity on the house of a businessman at Nareesh More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- i. One(1) Khukri measuring about 13 inches in length made of iron including its wooden butt was recovered from the possession of accused Ajit Roy (23) S/O Lt. Pranbally Roy of Dakshin Shantinagar, Binaymore P.S Bhaktinagar Dist. Jalpaiguri
- ii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Raj Mandal(20) S/O Akhil Mandal of Dakshin Shantinagar, Binaymore P.S Bhaktinagar Dist. Jalpaiguri
- iii) One (1) iron made Chopper measuring approx 16 inches length including wooden handle recover from the possession of accused Palash Barman (23) S/O Purna Barman of Bholanath Para Thakurtala PS Bhaktinagar Dist Jalpaiguri.
- iv) One(1) iron sword measuring about its 2 ½ ft including iron blade and wooden handle, recovered from the possession of accused Soumitra Roy (21) S/O Shibu Roy of Bholanath Para Thakurtala PS Bhaktinagar Dist Jalpaiguri.

Thereafter all the articles were seized in-between 22.05 hrs to 22.25 hrs. Issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest them as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 05 arrested accused persons namely (1) Ajit Roy (23) S/O Lt. Pranbally Roy of Dakshin Shantinagar, Binaymore P.S Bhaktinagar Dist. Jalpaiguri (2) Raj Mandal(20) S/O Akhil Mandal of do (3) Soumitra Roy (21) S/O Shibu Roy of Bholanath Para Thakurtala PS Bhaktinagar Dist Jalpaiguri (4) Palash Barman (23) S/O Purna Barman of do and (5) Subhanikar Sarkar (24) S/O Nirmal Sarkar of Purba Fakdaibari PS Bhaktinagar Dist. Jalpaiguri and 09/10 others unidentified persons for such assemble with deadly weapons and arrange for its investigation.
