I would like to inform you that I was married to Sri Jayanta Debnath son of Sri. Jagadish Debnath, On the 11<sup>th</sup> day of May 2013, and we have Son Name Ayush Debnath (7 years), since the beginning of our marriage my husband had started rigorous mental and physical torture upon me the main reason behind which was his demand for money. After every 10 or 15 days my husband and his family demanded money from me and my family as I belong to an economically weak family it was not possible for us to fulfil their demand every time but whenever we failed to fulfil their demand my husband and his family tortured me they used to beat me badly and even my father in law (Sri. Jagadish Debnath) used to join hands with my husband and used to beat me. Although I was suffering badly but I was enduring the Torture for the sake of my child But On 20<sup>th</sup> October 2020, my husband forcefully thrown me and my son out of their house and sent me to my father's house since then he kept on asking for money or Divorce if I fail to give him money, after 5 months of this incident my husband suddenly came to my Father's house and took the custody of my son. After this incident he has never allowed me to speak to my son neither he let me meet him and when I residing my father's house during this time my husband suddenly came to my Father's house several times and tortured me Physically and mentally. That my husband continuously threat me over telephone he can murdered me if I fail to give him money or divorce and always mentally harass me, On 31<sup>st</sup> May 2021 I came to Know that my husband had married a woman namely Rinku Prasad with the help of above mentioned accused persons and their family members.

I therefore request you to take necessary and lawful action against them and make me obliged.
