In producing herewith one accused person named Suvendu @ Subhendu Roy( 31) S/O- Mridul Chandra Roy of Bikashnagar ,B.S.F. Road ,Salugara PS- Bhaktinagar Dist- Jalpaiguri along with seized the following seized articles :- (1) 31 (thirty one ) bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufactured by Himalayan Endeavour PVT. Ltd. Siliguri , West Bengal. (2) 4 (four ) bottles of Tuborg premium beer each bottle containing 330 ML. manufactured by Carlsberg India Pvt.LTD. (3) 8(eight) bottle of Kingfisher premium Lager beer each bottle containing 330 ML. manufactured by united Breweries Ltd. (4) 01(one) bottle of Royal Castle blue premium whisky containing 750 ml. manufactured Mount Distilleries LTD. (5) 02(two) bottles of Royal Stag Delux Whisky each bottle containing 750ML. manufactured by Aroma India Pvt.LTD. (6) One (1) bottle of Officers Choice Delux Whisky containing 375 ML. manufactured by Allied Blenders and Distillers Pvt. Ltd. (7) 01(one) bottle of MacDowell's No-1 Whisky. Containing 750 ml. manufactured manufactured by Cosmos Beverages PVT. Ltd. And (8) 01(one) bottle of Officers Choice Delux Whisky containing 750 ML. manufactured by Allied Blenders and Distillers Pvt. Ltd.

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Suvendu @ Subhendu Roy( 31) S/O- Mridul Chandra Roy of Bikashnagar ,B.S.F. Road ,Salugara PS- Bhaktinagar Dist- Jalpaiguri to the that today on 09/06/2021 while I was performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO-561 date 09/06/2021 received a specific input from the source at 22:25 hrs. that the above noted person has kept huge numbers of illicit liquor in his house at Bikashnagar Salugara BSF Road in order to clandestinely dispose the same. Accordingly the fact is informed to O/C Matigara PS and as per his direction I along with ASI Biswajit Saha , CV-619 Dharmendra Roy and Cv-14 Labanamoy Barman left for Bikashnagar Salugara BSF Road under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the house where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his shop in conceal position. On searching found huge numbers of Himalayan Gold country made spirit containing 600 ml. each and other brand of illegal liquor .On being interrogation he could not produce any valid documents in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 08 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 22:55 hrs to 23:20 hrs. On being asked he stated that he kept the same with a view to sale and supply at Patiramjote area area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Kali Pada Roy (48) S/O- late Khagen Roy of Patiramjote Kalabagan PS- Matigara Dist- Darjeeling as per proper section of law.
