I have tried to contact him through his phone number but his number is out of reach and thereafter, I contact with his one of the relatives and he also did not disclose me his whereabouts.

That I have purchased the vehicle with financial assistance and I have been paying the E.M.I. to the finance company. The above person has taken the money (salary) in advanced and has not turn up and also kept my vehicle for his wrongful gains. I along with my family members and others were remain busy in order to locate my said vehicle and also the whereabouts of the said person who had taken away my said vehicle and I could not lodge the written complaint in due time and some delay has been caused.

I, therefore, request you to kindly investigate into the matter properly after treating this complaint as an F.I.R. and please take necessary legal steps against the accused person and also recover my vehicle as early as possible and oblige thereby.
