

Today i.e 11/06/2021 at 05.55 hrs I, ASI Anupam Roy of NBMC OP along with C/500 Mayaram Oraon, CV/665 Raju Sarkar, CV/920 Kamal Barman and LC/271 Basabi Barman while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB74/8035 at different area under NBMC OP in course of which he received an information from source that one female person is selling Liquor illegally in huge quantity in a clandestine way at road side petty shop near Amit Agarwal Bhawan near AH - 02. As soon as after receiving information he informed the matter to O/C NBMC OP and as per his order and instruction I along with force conducted raid at near Amit Agarwal Bhawan near AH - 02. During raid I found one Smt Karnobala Dutta (F/60 yrs), W/O - Lt Prem Dutta, of - Kawakhali Bazar, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling is (i) 20 (Twenty) bottles of Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 Ml Rs. 100/- each totaling amount of Rs 2000/- and (ii) 05 (Five) pouches of Officer Choice Whisky Price of each pouch Rs 140/- totaling an amount of Rs 700/- hidden inside her shop and selling it to the customers in concealed manner. Accordingly, I seized the above noted articles in presence of police witnesses and lady police personnel, I demanded papers and license / cash memo of those seized articles but she failed to produce any documents in support of her possession of above noted illicit liquor. On interrogation, she disclosed her name as mentioned above and admitted that she procured the liquor illegally and had been selling the same illegally to the people. I, accordingly, seized those illicit liquors U/S 102 CrPC in presence of witnesses after preparing proper seizure List duly signed by the witnesses as well as the accused and also labeled the same. Then, I arrested her U/S 41 CrPC with help of lady police with keeping in mind modesty and proper health measures. The search, seizure and label were made from 06.15 hrs to 06.45 hrs. Then we left the place with the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the female accused person named Smt Karnobala Dutta (F/60 yrs), W/O – Lt Prem Dutta, of – Kawakhali Bazar, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling and kindly arranged for its investigation.
