However the above persons violated the said rules and norms which has been duty promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India. I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply my lawful instructions and kept on roaming within the area without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.
