Sir,

In producing herewith one (01) person namely Bishnu Paswan(21), S/O- Santosh Paswan of Beldangi, Tumba Jote, PS- Matigara, Dist- Darjeeling along with seized articles viz., 20 (twenty ) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 12 liters, value Rs 2000/-, I PSI Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person to the effect that today on 11.06.2021 at 19.25 hrs received a source information that the above noted person selling and storing of liquor at his house without any valid license. Accordingly the fact was diarized vide Matigara PS GDE No- 485, Dt. 11.06.2021 and shared the information with O/C Matigara PS and subsequently, as per his kind direction myself along with ASI- Subhendu Das, ASI - Nitai Mandal C/1035 Santosh Rabidas, CV/155 Sukumar Das and CV/387 Sukumar Barman had been to Beldangi, Tumba Jote to verify the veracity of the information. On reaching at Beldangi, Tumba Jote at 20.15 hrs and being pointed by my reliable source. We cordoned the house with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the house. On being search of his house in presence of available witnesses the above noted seized articles are found inside his house. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place the persons who were having liquor at the house managed to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 20.45 hrs to 21.15 hrs.

Therefore I pray before your good self that a specific case against the above noted accused person namely Bishnu Paswan(21), S/O- Santosh Paswan of Beldangi, Tumba Jote, PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
