ASI. Subhnedu Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Pradip Ghosh (57/M) S/O Lt. Sachindra Nath Ghosh of Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling under arrest along with following seized articles viz ; (I) 26 (Twenty Six) bottles of Himalayan Gold Country Spirit each bottle containing 600ml. and marked as "Exhibit-A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 600ml. taken out as sample from "Exhibit-A" for examination and marked as "Exhibit-A-1 (Grand total 26 X 600 ml.=15.6 Ltrs.) under seizure list (which is enclosed herewith) to the effect that on 11.06.2021 at 20.05 hrs received a secret source information that one person namely Pradip Ghosh (57/M) S/O Lt. Sachindra Nath Ghosh of Shivmandir, Po- Kadamtala, PS- Matigara, Dist- Darjeeling has stored huge quantity of Illicitly distilled liquor and country spirit at his at his Shop without any valid license. Diarized the matter vide Matigara PS GDE No.489 Dt.- 11.06.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with PSI Shekhar Adhikary, ASI Nitai Ch. Mondal, Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Shiv mandir Bazar to verify the veracity of the source information. On reaching at the spot at 21:10 hrs it was found that huge quantity of Illicitly distilled liquor and Country Spirit stored in the Shop of Pradip Ghosh who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the Shop. But we apprehend the above noted person namely Pradip Ghosh. There after I called two independent witnesses namely i) ASI Nitai Ch. Mondal of Matigara PS and (ii) Const- 1035 Santosh Rabi Das of Matigara PS and in the very presence of those witnesses I search the Shop and seized the above noted Illicitly distilled liquors and country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Pradip Ghosh. On being asked the said person failed to produce any document for selling and storing liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 11/06/21 in between 21:25 hrs to 22:05 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Pradip Ghosh (57/M) S/O Lt. Sachindra Nath Ghosh of Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said Shop and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Pradip Ghosh (57/M) S/O Lt. Sachindra Nath Ghosh of Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
