Accordingly, diarized the fact in the General diary vide NJP PS dated 11.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava and CV/824 Niru Kr Yadav All of NJP PS, SPC left for Ghorar Bari to work out the information in hand. At about hrs we arrived at Ghorarbari and being shown and identified by the source we held raid at the house of accused Kamal Roy and managed to intercepted him. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor.
