Sub: Complaint against owner, namely, Sanjay Paul and manager, namely, SanjibDey of Life Line Nursing Home.

Sir.

With due respect, I, Md. NadimAbedin, s/o: Late ZainulAbedin, r/o: Matigara, P.O. & P.S. Matigara, Dist- Darjeeling would like to draw your attention about the following facts:

 That my father, namely, ZainulAbedin was diagnosed with COVID virus infection and thereby admitted to Life Line Nursing Home, on 14/05/2021, situated at NH31 Bypass Road, opposite of ATC godown, Champasari Road, Checkpost, Siliguri, Dist- Jalpaiguri.

2. That by 31/05/2021 I already paid to the said nursing home authority a bill amounting 7,15,000/- INR i.e., Seven lakh and fifty thousand rupees.

That on 31/05/2021 the nursing home authority demanded more money for security deposit and on asking they demanded to provide them a blank cheque of INR 2,00,000/- (Two lakh rupees), and as the treatment was going on and fulfilled their demand of blank cheque.

4. That on 01/06/2021 the said nursing home authority informed the demise of the patient and provided a bill amounting INR 10,71,862/-(Ten lakh seventy one thousand eight hundread and sixty two rupees.)

That thereafter when we reached the nursing home to collect the dead body of my deceased father, the manager of said nursing home, namely, SanjibDey demanded that we have to pay INR 3,44,000/- (rupees three lakh forty four thousand) excluding the blank cheque, otherwise they won't leave the dead body to us.

That thereafter when we disclosed that we don't have that much money, they agreed to settle for an amount of INR 30,000/- (Thirty thousand), and they further mentioned to collect the blank cheque after few days.

That thereafter I got busy with the final rituals for four days and then we went to the nursing home to collect the blank cheque, but they refused to give the cheque back and started to misbehave, and threatened me that they will bounce the cheque, on requesting a several times they again said to come after few more days.

8. That as per their instruction I again went to the nursing home to collect the cheque, but again they started to misbehave, used foul and filthy languages to me under the instruction of the manager, namely, SanjibDey and the owner, namely, Sanjay Paul, and all of them started to physically assaulting me and denied and refused to give the cheque back.

9. That thereafter I informed the IC of Bhaktinagar Police Station, and with his help, I got the cheque back.

Hence, on the basis of above mentioned facts it is my most earnest request to you that please take the necessary action against the Life Line Nursing Home authority including the manager, namely, SanjibDey, and the owner, namely, Sanjay Paul, and provide me the legal relief that I deserve and please take necessary steps to prevent this kind of incident further.
