In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Rajat Saha (40 yrs) S/O- Lt. Biswanath Saha of Sukanta Nagar, near Green Avenue, Ward No-38, PS-Bhaktinagar, Dist-Jalpaiguri, (ii) Rajib Mukherjee (52 yrs) S/O- Manoranjan Mukherjee of Suryasen Colony, Block-B, near Hari Mandir, PS-NJP, Dist-Jalpaiguri, (iii) Ranjit Paswan (42 yrs) S/O- Lt. Ram Prokash paswan of Sraban Nagar, Bagrakote, Ward No-18, PS-Siliguri, Dist-Darjeeling, (iv) Dipak Paswan (25 yrs) S/O- Lt. Kameswar Paswan of Sraban Nagar, Bagrakote, Ward no-18, PS-Siliguri, Dist-Darjeeling, (v) Nupur Deb (42 yrs) S/O- Lt. Satya Deb of hatiyadanga, Fakdaibari, near River Side, PO-Ghugumali, PS-Bhaktinagar, Dist-Jalpaiguri and (vi) Chinibasi Ghatak (4 0yrs) S/O- Lt. Tara Chand Ghatak of South Shanti Nagar, near Bhabesh More, PS-NJP, Dist-JPG alongwith two TOTO viz- (i) Toto blue colour without number & (ii) Toto red colour without number. I, SI Uttam Kumar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 14.06.2021 at 18.45 hrs during my R/T Mobile Van duty had been to NTS More area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons. Two of them namely Chinibasi Ghatak and Nupur Deb were roaming with their TOTOs noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
