I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 14.06.2021 at about 19:25 hrs while performing mobile petroling duty at Panitanki More area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Karan Agarwala (27) S/O Pradip Kr Agarwala of Seth Srilai Market, Ward No. 11, PS- Siliguri, Dist-Darjeeling (2) Sumanta Paul (36) S/O Lt. Sishutosh Paul of New Paul Para, Sreema Sarani, Ward No. 38, PS-Bhaktinagar, Dist-Jalpaiguri (3) Soumyadeep Saha (28) S/O Swapan Saha of Kanailal Dutta Road, Hakimpara, Ward No. 15, PS- Siliguri, Dist- Darjeeling (4) Ajit Sha (35) S/O Kameswar Sha of Jhankar More, Ward No. 04, PS- Siliguri, Dist- Darjeeling (5) Samrat Dhar (38) S/O Ranjit Dhar of Hakimpara, Rishi Arobinda Road, Ward No. 12, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647-ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COV!D-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Karan Agarwala (27) S/O Pradip Kr Agarwala of Seth Srilal Market, Ward No. 11, PS- Siliguri, Dist-Darjeeling (2) Sumanta Paul (36) S/O Lt. Sishutosh Paul of New Paul Para, Sreema Sarani, Ward No. 38, PS-Bhaktinagar, Dist-Jalpaiguri (3) Soumyadeep Saha (28) S/O Swapan Saha of Kanailal Dutta Road, Hakimpara, Ward No. 15, PS- Siliguri, Dist-Darjeeling (4) Ajit Sha (35) S/O Kameswar Sha of Jhankar More, Ward No. 04, PS- Siliguri, Dist-Darjeeling (5) Samrat Dhar (38) S/O Ranjit Dhar of Hakimpara, Rishi Arobinda Road, Ward No. 12, PS- Siliguri, Dist-Darjeeling arrange for its investigation.
