In producing herewith one arrested accused person namely Danesh Mahammad (30) S/O-Lt Dobir Mohammad of Purba Pamli near Tista Cannel , PO-Khunia, PS-Chopra, Dist-Uttar Dinajpur along with the following seized article as per seizure list:

- 1. One automatic Pistol with wood clamped butt measuring approx 04 inch, body measuring approx 02 inch and barrel measuring approx 04 inch having one striking pin, striking hammer and trigger in working condition loaded with one magazine contained two live ammunitions engraved as "7.62 KF" each marked as Exhibit-A,
- 2. One empty magazine marked as Exhibit-B.
- 3. One Black Coloured Realme Mobile handset along with Vodaphone SiM No. 8991671923898982965 SY

(The above noted Pistol loaded with magazine containing two live ammunitions seized from the exclusive possession of Danesh Mahammad (30) s/o-Lt Dobir Mohammad of Purba Pamli near Tista Cannel ,PO-Khunia, PS-Chopra, Dist-Uttar Dinajpur which was concealed on the left side of his waist underneath the shirt , One empty magazine recovered from his right side pant pocket and the mobile handset from his left side pant pocket)

I,SI Nur Alam Siddik of Detective Department, SPC, do hereby lodge a written complaint against the above mentioned accused to the effect that on 16.06.2021 at 19.05 hrs I received source information that a person aged about 30/32 yrs is illegally possessing a Pistol and roaming at Bhalobasha More under NJP PS area with a view to sell the pistol at Bhalobasha More area. The information was diarized vide DD, SPC GDE No. 119 dated 16.06.2021. After sharing the information with ACP DD SPC and as per direction, I along with ASI Proloy Bhattacharjee, ASI Abu Taleb, Const. 371 Syshanta Dey, Const-945 Krishna Barman and Const-562 Utpal Saha rushed to Bhalobasha More to work out the information. It refers to DD SPC GDE No-120 dated 16.06.2021.

On reaching at near Bhalobasha More at about 19.50 hrs, keeping the police vehicle at a good distance, myself along with my officers and forces started walk towards the exact location. As indicating my source, I along with requaccompanying officers and forces cordoned the place in silence at Bhalobasha More and found that one person is roaming here and there. In this situation, seeing our police party he tried to flee away but after hot chase, our police party managed to apprehend him. In presence of local witnesses, I thoroughly interrogated the apprehended person and he disclosed his name and address as above. On search above noted articles were recovered from his

exclusive possession. On demand he could not produce any document in respect of the possessed pistol, so I seized and labelled the above mentioned articles duly signed by the accused and the witnesses.

During interrogation, he confessed his guilt before us and stated that he procured the above mentioned pistol illegally and came at Bhalobhasa more with an intension to sell the above mentioned pistol and ammunitions for his wrongful gain. The seizure was made between 20.25 hrs and 21.15 hrs. I arrested him at 21.15 hrs U/S 41 Cr.PC.

Hence, I pray that a specific case may kindly be started against the accused person namely namely Danesh Mahammad (30) s/o-Lt Dobir Mohammad of Purba Pamli near Tista Cannel ,PO-Khunia PS-Chopra Dist-Uttar Dinajpur under proper section of law and arrange for its investigation.
