Sir.

I, SI Prosenjit Dey Sarkar of Siliguri PS, SPC do hereby submit this written complaint against accused Jiban Singh @ Tushar Das S/O- Lt. Nil Kumar Das of Uttar Haldibari PS Kumargram, Dist- Jalpaiguri, Chairman of Kamtapur Liberation Organisation, his associates and others, to the effect that today on 17/06/21, I have come across a video in the social media, in which Jiban Singh is seen along with 09 other suspected militants in camouflage dress, armed with sophisticated weapons at an undisclosed jungle location.

In the video, he has made a speech of about 06 minutes 41 seconds in which he has made allegations the State Government and the State Chief Minister's namely Sri Jyoti Base, Sri Buddhadeb Bhattacharjee and Smt. Mamata Banerjee. He has also spoken in favour of the present GCPA (Greater Coochbehar Peoples Association) leader Ananta Maharaj, He has urged the people of Kamtapur, from Malda to Sutia to raise to the occasion, to regain their motherland i.e. Kamtapur from the hands of the outsiders by any means. He has threatened that, only the Rajbanshi people will rule and take control of their Motherland "Kamtapur" at any cost.

The Kamtapur Liberation Organisation, a militant outfit operating in Assam and West Bengal, which came into existence in 1993 has been consolidating its position in the fourteen Districts in Assam and eight Districts in West Bengal, both organizationally and in terms of weapons and cadres, to achieve the objective of a separate "Sovereign Kamtapur State". They are also resorting to terrorism in the form of killing innocent civilians and security forces and engaging in other violent activities including looting, kidnapping, land mine and bomb blasting, and are also involved in terrorism.

The Ministry of Home Affairs vide a Notification dated 31st October 2014, in exercise of the powers conferred by clause (a) and of sub section 35 of the Unlawful Activities (Prevention) Act, 1967, have listed the Kamtapur Liberation Organization, all its formations and frontal organizations as a banned Terror Organisation, in the First Schedule of the UAPA Act. There are also intelligence inputs that the banned outfits KLO (Kamatapur Liberation Organization), NDFB (National Democratic Front of Bodoland), ULFA (United Liberation Front of Assam) and NSCN (National Socialist Council of Nagaland) (Khaplang Group) had a secret meeting on 17th April 2015 and they have taken resolution that they will liberate their motherland by joint actions. These outfits have formed a new platform named and styled as The United National Liberation Front of Western South-East Asia (UNLFWSEA). In a joint declaration the new organization has declared that they will not abide the Indian Constitution and they will organize the arms struggle against the atrocities committed by Indian Army, other para-military forces and police. There are intelligence inputs that KLO had newly recruited the cadres from

North Bengal and Lower Assam and they are being imparted arms training in Myanmar with the help of NDFB and NSCN (Khaplang).

It is also gathered that in pursuance of criminal conspiracy they are creating terror to the public in general, collecting funds by terrorism and organizing arms training camp for the youths of Assam and North Bengal to wage war against the State, to obtain their goal, that is a separate state of Kamtapur, by arms rebellion.

Hence, I pray that a specific case against u/s 121/121A/122/124A/153(b)/120(B) IPC r/w Sec 10/13/16/17/18/18A/18(B)/20 of UAPA may kindly be started against Jiban Singh @ Tushar Das S/O- Lt. Nil Kumar Das of Uttar Haldibari, PS- Kumargram, Dist- Jalpaiguri, Chairman of Kamtapur Liberation Organisation, his associates and others, and arrange for its investigation.
