This is to bring this year notice that MD Salam Haque resident of 108 Choto Kultibori had taken a construction contract of a 2 storey building in Chelopaphri on 17th Feb, 2021 at INR 18,00,000/- (Complete finishing) from my father Mr. Bhakta Kumar currently residing on rent at Pradham Nagar, Baghaj colony.

However even after 3 months of the contract MD. Salam Haque did not complete even  $\frac{1}{3}$  of the work but took an amount of INR 11,57,000 + 24,000 (Paid to carpenters directly) from my father. When I came back from my work place to Siliguri and enquired about <sup>28th May</sup> the bills of the amount he took. MD. Salam Haque could not show the entire bill. He only managed to give me system generated bill of around 4,00,000/- rest were all hand made bills of around (3,00,000/-) more. When I asked about additional 4,47,000/- he said this was for workers payment, when I requested for the attendance register he refused to show me rather threatened to beat me (Prayanta Rai) through the workers. Post the whole calculation I could figure out that MD. Salam Haque cheated my father and took all the amount and did not complete the job he has assured us to complete.

he could not show me bill he rather started  
to accuse me and threaten me.

After the contract was cancelled later after 10  
days he started calling from multiple  
numbers from different numbers and threatening  
myself (Priyanka Rai) to murder and rape  
me wherever I will be. Not only to me  
MD. Salim Haque also called Govind from  
Cheta Paphri who works as an electrician  
and accused him and asked to pass a  
message that he will kill me (Priyanka Rai)  
at my cost.

MD. Salim Haque initially had also shared  
inappropriate pictures with me on WhatsApp  
without my consent. I ignored me since  
because I was worried that my construction  
work would be compromised.

I am extremely worried about my safety  
from MD. Salim Haque as well as for my  
parents. I would request you to kindly  
consider me same and take strict action.
