I, S.I. Ajmal Haque of Khairabari PS, Dargeeling would like to inform you that on 18/6/21 base on the written complain of the complainant namely mistaramanda Mital Saha has been initiated a specific case vide KH B PS case no 167/21 dt 18.06.21 ut 489A/489B/489C/489D IPC against a/cd. namely Subrata Deb Nath (Imp) s/o Lt. Sunil Deb Nath, of Dawanig more, New Rangla, Sarat nagar, Tati, P.O. - Matigara, Dist. Dargeeling who was trying to use fake Indian currency note as genuine to the complaint, on being interrogated the said a/cd confessed that he used to make/print the said to be forged Indian currency using one colour printing machine. On being questioned he confessed that he made the forged Indian currency recovered from his possession using one colour printing machine. He also further added that one a/cd. namely Amit Limboo s/o Lt. Kaku Limboo of Kadamtola, Durgamandir, P.O. - Matigara, Dargeeling provided/supply the printer & accompanied him in using the forged note to the public at P.W.D. more under Khairabari PS. Accordingly myself along with ASI Tanmay Kundu, ev. 807nd S. N. was ev-732 Prashanta Singh went to place being lead by the a/cd (1) (Subrata Deb Nath) vide KH B PS case no- 646 - s manage to secure a/cd at a/cd namely Amit Limboo observing all formalities, S.I. Basudeb Guha of Matigara PS (SPC) also accompany us as our request. Thereafter we return to PS along with a/cd. Subrata Deb Nath & a/cd. Amit Limboo.

During further interrogation & cross verification of their statement it was learnt that from the statement of accused persons namely Subrata Deb Nath that he conceal the

printer machine in his home in a hidden
~~concealed~~ place by which he made the forged
 fake Indian currency note. Accordingly myself
 along with ASI Tanmay Kunder, CV-807-md.
 Sawwas, CV-732 prasanta singha & @ced more
 to Dawani more under meeting ps & informing
 the matter si Basudeb loka over the telephone.
 Accordingly, SI Binul Hoque & ASI Tanmay
 Kunder, CV-807-md. sahamawar; CV-732-pra
 shanta singha with @ced. Subrata singha Deb Nath
 reached at his home situated at Dawani more
 at about 20:35 hr. As identified & lead by the
 @ced. Subrata Deb Nath entering into the room at
 house of @ced. Subrata Deb Nath which his mother
 namely Usharani Deb Nath opened the door then his
 mother stated that Amit kumbod taken the same
 machine in the afternoon. Then he printing to
 find out the papers used in printing forged
 note, he took out one sharp cutting objects
 & tried to commit suicide by cutting his throat.
 He has sustain covered bleeding injury
 & fell down on the floor. It was so unexpec-
 ted & puzzle for a while & immediately tried
 to shift him to hospital for medical assis-
 tance but on hearing in copy of his mother
 the local relatives assemble there and restrain
 @ced from shifting him to hospital. Thereafter his
 family member shifted him to NRMH & hospi-
 tal where he has been admitted in critical
 condition. Talk to the family members & pro-
 see proper treatment.

So I therefore requesting you to take
 necessary action in this regards.
