In producing herewith eight arrested accused persons who disclosed their names as (i) Chinmoy Roy (18 yrs) S/O- Mohendra Roy of Sipaipara, PS-NJP, Dist-Jalpaiguri, (ii) Prafullya Barman (42yrs) S/O- Biren Barman of Suryasen Colony, Block-E, PS-NJP, Dist-Jalpaiguri, (iii) Sankar Paul (26yrs) S/O- Bishu Paul of Bholamore, Bakravita, PS-NJP, Dist-Jalpaiguri, (iv) Rabi Hazra (54yrs) S/O- Lt. Motin Hazra of Ambika Nagar, near Bazar, PS-NJP, Dist-Jalpaiguri, (v) Raj Roy @ Abhishek (19yrs) S/O- Dipak Roy of More Bazar near Lal Bazar School, PS-NJP, Dist-Jalpaiguri, (vi) Narayan Behera (32 yrs) S/O-Debraj Behera of 148 D, Central Colony, Ward No-32, PS-NJP, Dist-Jalpaiguri, (vii) Nand Kishore Sahani (70 yrs) S/O- Lt. Bhikhari Sahani of Bagrakote, Ward No-20, PS-Siliguri, Dist-Darjeeling & (viii) Mithu Das (20 yrs) S/O- Bishu Das of Ambikanagar, Road No-2, PS-NJP, Dist-Jalpaiguri alongwith their seven vehicles viz- (i) Toto blue colour without number, (ii) Toto green colour bearing No. WB 73F/2383 & (vii) Toto blue colour without number, (v) Toto blue colour without number, (vi) Toto blue colour bearing No. WB 73F/2383 & (vii) Toto blue colour without number. I, SI Raju Chhetri of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 19.06.2021 at 12.35 hrs during my Mobile Van duty myself alongwith my accompanied force had been to Mabirsthan area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 and Order no.753-ISS/2M-22/2020 dt.14.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
