Sir,

In producing herewith six (06) arrested accused persons who disclosed their names as (i) Ajit Ch. Saha (46 yrs) S/O- Lt. Niranjana Saha of Chayan Para, Romonisha More, PS-Bhaktinagar, Dist-Jalpaiguri P/A- Gangarampur Sahapara, PS- Gangarampur, Dist- Dakshin Dinajpur, (ii) Promod Prasad (53yrs) S/O- Raghu Nath Prasad of Maharaj Colony, Ward No-4, near Vishal Mega Mart, PS-Siliguri, Dist-Darjeeling, (iii) Prakash Kr. Prasad (26 yrs) S/O- Promod Prasad of Maharaj Colony, Ward No-4, PS-Siliguri, Dist-Darjeeling, (iv) Suvam Yadav (26 yrs) S/O- Suresh Yadav of Maharaj Colony, Ward No-4, near Vishal Mega Mart, PS-Siliguri, Dist-Darjeeling, (v) Kalyan Choudhury (34yrs) S/O- Tapan Kr. Choudhury of Babupara, Govt. Housing, Ward No-27, PS-Siliguri, Dist-Darjeeling, (vi) Prosenjit Ghosh (33 yrs) S/O- Dilip Ghosh of Ghoramore, Nayapara, PS-NJP, Dist-Jalpaiguri, I, PSI Biswajit Sarkar of Siliguri PS, SPC do hereby lodge this complaint against the above noted arrested accused persons to the effect that, on 2.06.2021 at 18.25 hrs during my Mobile Van duty myself alongwith my accompanied force had been to Baghajatinpark area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 and Order no.753-ISS/2M-22/2020 dt.14.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
