I, Suman Sengupta, Son Of Ashoke Sengupta, Assistant Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electric lines and property of WBSEDCCL. At Around 11:30 hrs on 23.06.2021 morning Power House Customer Care center received information regarding damage of electric lines in Panchavati Housing Complex, beside Ravi Auto Sevoke Road, Siliguri. On reaching the site, the maintenance van of Power House Customer Care Center found that one Vehicle with the no WB-73-D-3817, had broken one Electric Pole and caused other damages to the Electric Lines which are the property of WBSEDCCL. The total damages caused by the vehicle are approximately around Rs 23318/- (Rupees Twenty Three Thousand Three Hundred And Eighteen Only). Thus you are requested to kindly initiate an investigation against vehicle no WB-73-D-3817 under Section 139 of the Indian Electricity act 2003 amended on 2007.
