In producing here with seven arrested accused persons namely 1)Tapan Ch Hore s/o Abani Kanta Hore of Netaji Nagar Champasari PS Pradhannagar Dist Darjeeling 2)Rahul Mahato s/o Ramesh Mahato of Samar nagar of PS Pradhannagar Dist Darjeeling 3) Debasish Banik s/o Khir Mohan Banik of Baghajatin colony of PS Pradhannagar Dist Darjeeling 4) Muni pradhan s/o Uday Pradhan of near D.P.S School of PS Pradhannagar Dist Darjeeling 5)Sanjay Singh s/o Thane Singh of Champasari more of PS Pradhannagar Dist Darjeeling 6)Anil Roy s/o Sarat Roy of Bagahjatin colony PS Pradhannagar Dist Darjeeling 7) Abhishek Kumar s/o Chawhan Roy of Mallaguri PS Pradhannagar Dist Darjeeling arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 25.06.2021 while performing special van duty received information that some persons were loitering with out gathering mask at Chmapasari More area. I along with ASI Anup Sarkar, CV-223 Sapan Chettri, C/1419 Ashis Roy had been to Gurung Basty Bazar area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. I, finding no other alternative, along with force apprehended them and I arrest them U/S 41C.rPC. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
