Sir,

In producing here with seven arrested accused persons namely 1) Sanu kr Singh s/o Bir bahadur Singh of Patibana PS Vaishah Bihar 2) Shyam kr Das s/o Satrudhan Das of Kadamgach Champasari PS Pradhannagar Dist Darjeeling 3) Swapan Dey s/o Dulal Dey of Panchanan Colony PS Pradhannagar Dist Darjeeling 4) Bholu Sahani s/o Ganga Sahani of Khalpara PS Siliguri 5) Rajan Kr Sha s/o Sambhu Sha of Gurung Busty PS Pradhannagar Dist Darjeeling 6) Ajay kr Yadav s/o Lt Sita Ram Yadav of Sngha pur PS Naya gaon Dist Begusarai Bihar 7) Kanai Pall s/o Lt Tapan Pall of old M.T.G road PS Pradhannagar Dist Darjeeling arrested accused persons namely arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 25.06.2021 while performing special van duty received information that some persons were loitering with out gathering mask at Gurung Busty Bazar area. I along with ASI Anup Sarkar, C/1411 Ashok Ray, C/1419 Ashis Roy had been to Gurung Busty Bazar area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. I, finding no other alternative, along with force apprehended them and I arrest them U/S 41 Cr.P.C. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
