Hence, they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 647-1SS/2M-22/2020 dated 15.05.2021 and Notification number 347-01.S.S / 2M-24/2020 dated 3rd June 2020 and Memo No 486-CS/2021 dated 24th April , 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State.

Accordingly, I arrested them u/s 41 CR.P.C in c/w the above case. Hence, I request you for starting a specific case u/s 188/269 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
